Presentation from Police Chief Kevin Jarriel

Chief Jarriel was away at the Chief Executive Training Program. Mayor and Commissioners reviewed the monthly activity report.

Discussion of Memorandum of Understanding with East Georgia Stat College

The purpose of this MOU is provided mutual assistance with East Georgia State College and the City of Twin City. City Attorney Rountree has reviewed and approved the agreement.

Discussion of quotes for Cox Field repairs from Hurricane Helene damage

The City Commission viewed quotes from Central Fence and Handi House.

Discussion of GDOT Transportation Alternatives Grant

Mayor Donaldson briefed the City Commission of (2) applications to the GDOT TA program. The first grant application would fund the sidewalk extension to ECI, and the second grant application would fund the Railroad Depot renovation.

Discussion of PlanFirst Application and review of City of Twin City Community Work Program (2023-2027)

Mayor Donaldson reviewed the accomplishments of the current Work Program (2023-2027). The City will be applying to the DCA for the PlanFirst designation, which formally acknowledges proactive planning done by local governments.

Discussion of Georgia Cities week April 21-26, 2025 and City- Wide Clean Up on Saturday, April 26, 2025

The Spring City Clean-Up will be held on Saturday, April 26th. The City will be picking up larger household garbage that week. The City will not accept tires. There will be a mailer sent out in the next City utility billing.
