Executive Session – Personnel

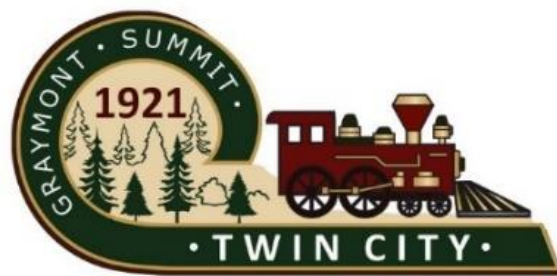
The motion to enter Executive Session was made by Commissioner Jesse Brown and seconded by Commissioner Moody. The motion was approved unanimously.

Presentation from Police Chief Hank Whriters

Discussion of rescission Order No#2 to pave portions of Gillikin and New Streets
