The City of Twin City is looking for newly certified or veteran police officers to join our team with the Twin City Police Department. TCPD is looking for honorable, motivated, and community-oriented individuals that have a drive to serve the citizens of Twin City.

Description

The Police Officer enforces federal, state, and local laws and protects life and property. This is a sworn position and will require the ability to perform basic patrol officer functions.

Full-time officers will be provided with a take-home car, necessary equipment, uniforms, less-lethal tools, and firearms.

Training

TCPD officers will be given yearly mandated training and provided with opportunities for specialty training such as Speed Detection, Interviews/Interrogations, Active Shooter response, Building clearing, Community policing, and Narcotics Investigations.

Examples of Duties

- Patrols an assigned zone in order to detect and deter criminal activity and traffic violations;
- Work rotating afternoon and night shifts
- Completes zone checks for assigned zones;
- Responds to calls relayed by communications officers, including domestic disputes, assaults, burglaries, traffic accidents, traffic enforcement lost or missing persons searches, public service duties, stranded motorists, and others;
- Conducts preliminary investigations into traffic accidents, crimes, and other incidents, including interviewing victims, complainants and witnesses, gathering information and evidence, securing crime scenes, and performs basic crime scene processing;
- Performs preliminary investigative work to include taking pictures, collecting statements, and lifting fingerprints;
- Apprehends, arrests, and processes offenders, including fugitives;
- Provides assistance and backup support to other officers and emergency service providers as necessary;
- Testifies in judicial proceedings as necessary;
- Completes all required reports and forms, including accident and incident reports;
- Prepares and serves criminal warrants;
- Performs Bailiff duties for Municipal Court;

Minimum Qualifications

- High School Diploma or GED;
- Or equivalent training, education, and/or experience; and
- Valid State of Georgia Driver's License;

- Must possess and maintain Georgia Peace Officer Certification;

Additional Information

Applicants will be disqualified if they have a felony conviction, a family violence conviction, or current illegal drug use. The selected candidate must complete the following requirements prior to starting work with the City of Twin City:

- Background Investigation (includes the applicant's work history, criminal history, professional references, personal references, neighborhood references, and management of personal finances).
